- 1) The entire fire protection system installed at the site should be maintained in excellent working condition for the any fire emergency.
- 2) The fire extinguishers handling and operational training to be imparted to the teaching/non-teaching/security staff of the school.
- 3) You will carry out testing, maintenance and refilling of all fire extinguishers/fire protection systems from competent person (Govt. Fire Licensed Agency) and necessary Form-'B' Certificate regarding the maintenance and operational condition of the Fire Fighting system to be submitted to the Fire Office as per the Sec.3 (3) of the Fire Act.2016, for every six months in month of January to July, failing of which this NOC shall be treated as cancelled.
